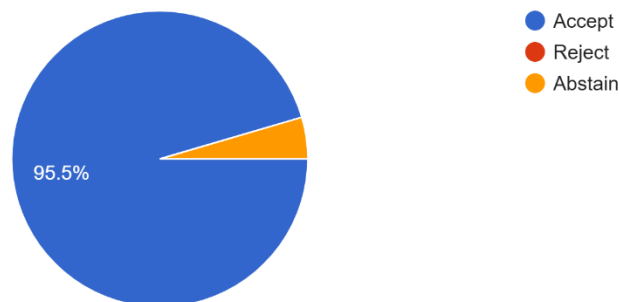

As per the SAWF Constitution:

16. ORDINARY GENERAL MEETING ("O.G.M.")

- 16.1. An O.G.M. shall be held once every year.
- 16.2. Exco shall decide the date, time, and place on which each O.G.M. shall be held.
- 16.3. The following persons shall be entitled to attend and speak at the O.G.M:
 - 16.3.1. All members of the Federation Council, as defined in 15.2;
 - 16.3.2. 2 (two) athletes' representatives from each Provincial Association who are elected by the Athletes' Commission of the Provincial Association
 - 16.3.3. The Patrons;
 - 16.3.4. All Honorary Life Members;
 - 16.3.5. Invited individuals shall include the Auditor and a representative of the Sports Confederation;
- 16.4. Notice of any O.G.M. of the Federation Council shall be sent to all Members not less than 21 (twenty-one) days before the date of such meeting which notices shall be accompanied by a proposed agenda as recommended by Exco.
- 16.5. The full motion which any Member wishes to be put to and considered by any O.G.M. shall be received not less than 14 (fourteen) days before the date of such meeting by the Secretary-General who shall distribute it by post and/or by hand, and/or by fax, and/or by electronic mail, together with the final agenda to all Members, the Athlete's Commission, and Associate Members, not less than 7 (seven) days before the date of such meeting.
- 16.6. The business to be transacted at the O.G.M. shall be:
 - 16.6.1. to read the notice convening the meeting;
 - 16.6.2. to read and confirm, with or without amendments, or to reject the minutes of the previous O.G.M., as well as the minutes of any S.G.M. held in the interim, and to consider any matters arising therefrom;
 - 16.6.3. to consider and to adopt, with or without modification, or to reject, any Resolution of which due notice has been given;
 - 16.6.4. to consider and to adopt, with or without modification, or to reject, the budget for the ensuing year which shall have been prepared by the Treasurer and considered and recommended by Exco.
 - 16.6.5. No resolution which has the effect of creating, amending, or repealing a by-law, regulation, or standing rule shall be binding unless the notice thereof has been given in terms of clause 15 hereof or such resolution has been ratified at the next Federation Council meeting.
